

Fortis CEO Anton van Rossum to Serve as Chairman of Fortis, Inc. Board of Directors

New York, NY May 7, 2001 - Fortis, Inc., part of international financial services provider Fortis [BSE: FOR and AMS: FOR], today announced that Fortis Chief Executive Officer Anton van Rossum has been elected Chairman of the Board of Fortis, Inc.

Mr. van Rossum was named Chief Executive Officer of Fortis and Chairman of the Boards of Fortis Bank and Fortis Insurance in September 2000. He is responsible for managing Fortis' extensive global insurance, investment and banking operations, including Fortis, Inc. Prior to joining Fortis, Mr. van Rossum was a Senior Partner at McKinsey and Company with management responsibility for its Brussels office. Mr. van Rossum holds a master's degree in Economics and Business Administration from the Rotterdam Erasmus University.

Mr. van Rossum said, "I am delighted to have been elected Chairman and look forward to helping Fortis, Inc. continue the successful execution of its strategy to build and manage a select portfolio of U.S. specialty businesses that are leaders in their respective markets."

Hendrik Jochem Hielkema, Vice-Chairman, Fortis, Inc. Board of Directors

Mr. Hielkema is a member of the Board of Directors of Fortis. Prior to his current position Mr. Hielkema was Vice Chairman of the Fortis Executive Committee and Chairman of the Management Committee of Fortis Insurance N.V. Mr. Hielkema started his career with Fortis in 1988 when he joined the Executive Board of Fortis AMEV N.V. (formerly N.V. AMEV, now Fortis (NL) N.V.). Before joining Fortis, Mr. Hielkema was a Senior Vice President at Chase Manhattan Bank and Chairman of the Executive Board of Nederlandse Crediet Bank. He earned a bachelor's degree in business administration from University of Oregon and a master's degree of business administration from Texas Tech.

Beth Bronner, Former President and Chief Operating Officer, ADVO, Inc.

Beth Bronner is the former President and COO of ADVO, Inc., the nation's largest full-service targeted direct mail marketing company. Before her position at ADVO, Inc. Ms. Bronner was President of the Health Division at Sunbeam Corporation. She has also held senior management positions at Citibank and AT&T. Ms. Bronner received a bachelor's degree from Vassar College and has a master's degree of business administration from the University of Chicago.
