

Assurant Finalizes Exclusive Distribution Agreement Extension with Service Corporation International and Completes Acquisition of Mayflower National Life Insurance Company

New York – July 2, 2007 – Assurant, Inc. ("Assurant") (NYSE: AIZ), a premier provider of specialized insurance and insurancerelated products and services, announced today that its exclusive preneed distribution agreement with Service Corporation International® ("SCI") (NYSE: SCI) has been extended three years through Sept. 30, 2013. In addition, Assurant purchased Mayflower National Life Insurance Company ("Mayflower") from SCI for \$67.5 million with available cash.

This agreement allows Assurant to distribute its preneed insurance products and services throughout the United States, Canada and Puerto Rico as the exclusive provider for SCI-owned funeral homes.

Assurant's acquisition of Mayflower was completed on July 1, 2007, following regulatory approval. The transaction will add approximately \$52 million to Assurant's annual net earned premiums.

"The extension of this exclusive distribution partnership with SCI, combined with the Mayflower acquisition, is consistent with Assurant's strategy of aligning itself with market leaders and illustrates our focus on long-term profitable growth in our key targeted growth areas," said Robert B. Pollock, Assurant's president and chief executive officer. "By leveraging our core capabilities, we expect new business written to generate returns consistent with the 14-16 percent range we have targeted for our Assurant Solutions segment."

Christopher Reznyk, senior vice president and preneed business leader, Assurant Solutions, said, "The additional business scale that we gain through Mayflower will allow us to service funeral home customers with greater efficiency. Our target market, age 65 and over, is projected to double over the next five years. This acquisition and distribution agreement extension positions us to implement programs that we have used successfully with other Solutions businesses and to more fully take advantage of the growing market for financially-safe preneed funding."

Preneed life insurance allows individuals to prepay for a funeral in a single payment or in multiple payments over a fixed number of years. The insurance policy proceeds are used to address funeral costs at death.
