

**GRAMM-LEACH-BLILEY ACT SAFEGUARDS RULE ADDENDUM**

This Gramm-Leach-Bliley Act Safeguards Rule Addendum (“GLBA Addendum”) is between the applicable Assurant entities (“Assurant”) listed in Schedule 1 – Assurant Entities (“Schedule 1”) and the dealer herein (collectively and individually “Dealer”) listed in Schedule 2 – Dealers (“Schedule 2”) and is made effective upon its execution by Dealer (“Effective Date”).

**RECITALS**

WHEREAS, Assurant and Dealer have previously entered into agreements; (“Agreement(s)”);

WHEREAS, this Addendum supplements those Agreements between Assurant and Dealer in regard to the GLBA;

NOW THEREFORE, Assurant and Dealer agree as follows:

Assurant, in connection with its actual or required performance of the services under an Agreement with Dealer, complies, to the extent applicable, with the GLBA Safeguards Rule (“Rule”), which was revised in October of 2021.

Assurant maintains an appropriate information security program that complies with the requirements of the Rule which appropriately and effectively protects and safeguards customer information.

Assurant completes a periodic review to evaluate and maintain continued adequacy of the established safeguards.

Upon Dealer’s written request, Assurant may provide documentation, no more than once annually, to Dealer to demonstrate Assurant’s continued adequacy with the established safeguards by the Rule.

All other terms and conditions of any Agreements remain unchanged and in full force and effect.
